

HILLCREST SCHOOL SCHOOL PARENT INVOLVEMENT POLICY

Hillcrest School has developed a written Title I parental involvement policy with input from Title I parents. *The policy is discussed at the annual Title I parent meeting and the School Site Council meetings and parent input is solicited to develop and revise the policy. Hillcrest has distributed the policy to parents of Title I students at the Annual Title I meeting, and other school-wide parent events, such as Back to School Night and parent teacher conferences. Additionally, the policy is posted on the school website.* The policy describes the means for carrying out the following Title I parental involvement requirements [20 USC 6318 Section 1118(a)-(f) inclusive].

Involvement of Parents in the Title I Program

To involve parents in the Title I program at Hillcrest, the following practices have been established:

- The school convenes an annual meeting to inform parents of Title I students about Title I requirements and about the right of parents to be involved in the Title I program. *The meeting is held at the beginning of the school year and all parents of Title I students are invited to attend.*
- The school offers a flexible number of meetings for Title I parents, such as meetings in the morning or evening. *The schedule for parent meetings is developed on an annual basis based on input collected through a parent survey.*
- The school involves parents of Title I students in an organized, ongoing, and timely way, in the planning, review, and improvement of the school's Title I programs and the Title I parental involvement policy. *The School Site Council with parent members of Title I students annually reviews and updates the School's Single Plan for Student Achievement (SPSA) which includes the Title I programs and the parent involvement policy to address the identified needs of the school.*
- The school provides parents of Title I students with timely information about Title I programs through a variety of communication opportunities, including the annual Title I meeting, monthly coffee with principal, parent teacher conferences, weekly/monthly newsletters, weekly/monthly automated telephone calls, school website, and school community coordinators targeted outreach.
- The school provides parents of Title I students with an explanation of the curriculum used at the school, the assessments used to measure student progress, and the proficiency levels students are expected to meet at the annual Title I meeting, Back to School night, and parent teacher conferences.
- If requested by parents of Title I students, the school provides opportunities for regular meetings that allow the parents to participate in decisions relating to the education of their children. *Parents are invited to serve on a variety of parent involvement committees, including the School Site Council, English Learner Advisory Committee, and Parent Teacher Association. Additionally, parent surveys are used to guide the development of parent involvement program, including meeting frequency and agenda.*

School-Parent Compact

Hillcrest School distributes to parents of Title I students a school-parent compact. The compact, which has been jointly developed with parents, outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement. It describes specific ways the school

and families will partner to help children achieve the State's high academic standards. It addresses the following legally required items, as well as other items suggested by parents of Title I students.

- The school's responsibility to provide high-quality curriculum and instruction

- The importance of ongoing communication between parents and teachers through, at a minimum, annual parent-teacher conferences; frequent reports on student progress; access to staff; opportunities for parents to volunteer and participate in their child's class; and opportunities to observe classroom activities

Building Capacity for Involvement

Hillcrest School engages Title I parents in meaningful interactions with the school. It supports a partnership among staff, parents, and the community to improve student academic achievement. To help reach these goals, the school has established the following practices.

- The school provides Title I parents with assistance in understanding the State's academic content standards, assessments, and how to monitor and improve the achievement of their children *in an ongoing manner through various meeting and training opportunities, including the annual Title I meeting, parent teacher conferences, and School Smarts.*

- With the assistance of Title I parents, the school educates staff members about the value of parent contributions, and in how to work with parents as equal partners *through regularly-held staff meetings and Parent Teacher Association (PTA) sponsored events.*
- The school coordinates and integrates the Title I parental involvement program with other programs, and conducts other activities, such as parent resource centers, *Leader in Me (LIM), Positive Behavior Intervention and Supports (PBIS), and School Smarts* to encourage and support parents in more fully participating in the education of their children.

Hillcrest School provides opportunities for the participation of all Title I parents, including parents with limited English proficiency, parents with disabilities, and parents of migratory students. School community coordinators, in addition, serve as the liaison to reach out to individual parents and provide additional support to empower them as meaningful partners in their children's education.*
